The Lighthouse Club is a charitable institution with two principal objectives. The first of these objectives is to provide assistance to those in need within the construction industry and to their dependents where a fatality has occurred. The second objective is to promote good fellowship and co-operation amongst members through a varied series of functions held throughout the year.

The Lighthouse Club was established in Hong Kong in 1986 and now has a membership of almost 800, with a wide cross-section of people associated with the construction industry being represented. Ordinary membership is open to all individuals connected with the industry, Associate membership is available to non-industry persons and Corporate membership is open to all corporate bodies connected with the construction industry.

The Lighthouse Club has a well-supported social calendar with events and functions taking place throughout the year. These include the Annual Dinner, Annual Ball, barbeques, race days, boat trips and so on. Every month the ever-popular “get-together” takes place at the Louis’ Steakhouse in Wanchai. The Lighthouse Club Golf Society is very active, with regular outings arranged in Hong Kong and throughout the region. Young members are also well-catered for, with an active Young Members Section (open to members under the age of 35 years) organising regular social and professional events.

In recent years, the Lighthouse Club has organised a number of successful seminars covering a broad range of topics of current interest to those associated with the construction industry.

The Lighthouse Club Charities benefit from the proceeds of all events and functions organised by the Lighthouse Club.

The Lighthouse Club has branches worldwide - in the Asia Pacific Region there are branches in Bangkok, Kuala Lumpur, Manila and Singapore in addition to Hong Kong.

The Lighthouse Club chose as its motto “*Aliis cum Humanitate*” which translates as “Humanity to Others”.

The Lighthouse Club Hong Kong Benevolent Fund is the only registered charity in Hong Kong devoted to those in need within the construction industry. The Fund provides financial assistance to victims of accident or illness, and to their dependents where a fatality has occurred. The Benevolent Fund has been in existence for almost two decades, and in recent years has been paying out more than HK\$1 million per annum to needy cases.

The Lighthouse Club James Battersby Educational Trust is intended to provide help to young people connected with the construction industry. The Trust’s objectives are to assist in the training in the industry of disadvantaged young people, or to assist with the education of children who are suffering hardship as a result of the death, injury or illness of a parent or guardian employed in the construction industry.
